

RURAL MUNICIPALITY OF ROSEDALE NO. 283

BYLAW NO. 07/2025

A BYLAW FOR PUBLIC DISCLOSURE STATEMENTS

Council of the Rural Municipality of Rosedale No. 283 in the Province of Saskatchewan enacts as follows:

Short Title

- 1. This Bylaw shall be referred to as the "Public Disclosure Bylaw".

Legal Requirement

- 2. This Bylaw has been created to comply with Section 142 of The Municipalities Act, SS 2005, c M-36.1 and Section 3.2 of The Municipalities Regulations.

Purpose

- 3. The purpose of this Bylaw is to avoid conflict of interests and to facilitate transparency within the Municipality.

Definitions

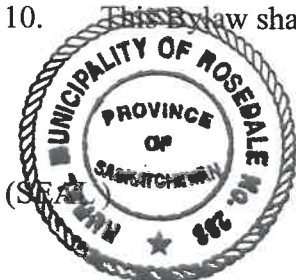
- 4. In this Bylaw:
(1) Act means The Municipalities Act, SS 2005, c M-36.1;
(2) Administrator means the Administrator of the Municipality, appointed by Council pursuant to Section 110 of the Act and is responsible for the overall management and administration of municipal affairs.
(3) Council means the Reeve and Councillors of the Municipality elected pursuant to the provisions of The Local Government Election Act, SS 1982-83, c L-30.1
(4) Municipality means the Rural Municipality of Rosedale #283.
(5) Reeve means the head of the Municipality's Council, elected to represent the Municipality, preside over Council meetings, and carry out various duties.

Public Disclosure Statements

- 5. Every member of Council shall file within 30 days of being elected a public disclosure statement with the Administrator on Public Disclosure Form 1 as attached hereto.
6. Every member of Council who has previously filed a public disclosure statement pursuant to Section 5 shall annually submit a declaration on or before November 30th in each year to the Administrator on Public Disclosure Annual Declaration Form 2 as attached hereto.
7. Every member of Council shall submit to the Administrator any material change to their prior disclosure statement on the Public Disclosure Statement Amendment Form 3 as attached hereto.
8. Council members must revise their disclosure statements any time a material change occurs or if they or another person notices an error or omission.

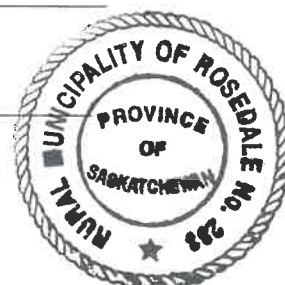
Coming Into Force
