A BYLAW OF THE R.M. OF ROSEDALE NO.283 IN THE PROVINCE OF SASKATCHEWAN FOR THE ESTABLISHMENT OF AN EMERGENCY MEASURES ORGANIZATION.

WHEREAS the Civil Defense and Disaster Act, Cap 417, RSS 1965, under Section Nine (9) provides for the establishment, organization, operation, and control of a local civil defense and disaster organization by municipal council:

AND whereas it is desirable in the public interest that civil emergency plans be prepared to meet emergencies created by disasters:

AND whereas it is necessary to ensure the continued functioning of the government of R.M. of Rosedale No. 283 during all emergencies:

THEREFORE the Council of the R.M. of Rosedale No.283 enacts as follows:

- There is hereby established an Emergency Measures Control Committee (i)which shall consist of the Reeve and at lease two members of Council who shall be appointed by resolution.
- (ii)The Emergency Measures Control Committee shall be responsible for:
 - Appointment of an Emergency Measures Organization Director/ Co-ordinator and other such employees as may be required.
 - (b) The review of all plans, programs, and expenditures related to emergency planning.
 - Submission to Council of estimates of expenditures for the (C) maintenance and operation of the Emergency Measures Organization.
 - Submission to Council at least twice per year of a progress (d) report of activities.
 - Submission to Council, for approval, of a municipal (e)emergency plan.
- (iii) There shall be an Emergency Measures Planning Committee comprised of heads of municipal departments and emergency services, or such other persons as may be deemed necessary to formulate a municipal emergency plan.
- The Chairman of the Emergency Measures Planning Committee shall (iv) be the Emergency Measures Director/Co-ordinator.
- (V) The Emergency Measures Director/Co-ordinator shall be responsible for stimulating and co-ordinating the development of a disaster plan for the municipality in co-operation with all government departments, agencies and voluntary services.
- (vi) Each municipal department of voluntary emergency services of the municipality shall make such plans and carry out such activities as are necessary to ensure a capability to meet their responsibilities in disaster.
- (vii) The Emergency Measures Organization of the R.M. of Rosedale No.283 shall be comprised of the Emergency Measures Control Committee, the Emergency Measures Planning Committee, municipal departments and all voluntary emergency services within the municipality.
- (viii) The Council may, from time to time, borrow, buy, appropriate and expend monies required to meet the ordinary operating expenses of the said organization.
- (ix) The Council may co-operate with other Councils of other municipalities for the purpose of jointly establishing and operating an Area Emergency Measures Organization.
