- 3. That the work or service shall be carried on within the Hanley-Rosedale Fire Protection District and the RM of Dundurn.
- 4. Rates for work and service set by each district shall apply for the use of its equipment and shall be paid between Fire Districts.
- 5. In the event for any reason, it may be necessary to cancel the Agreement, either parties by district may do so by giving written notice.
