BYLAW NO. 02/2021

A BYLAW TO MANAGE VEHICLE WEIGHTS

The Council of the Rural Municipality of Rosedale No. 283, in the Province of Saskatchewan enacts as follows:

This bylaw shall be referred to as the "Vehicle Weight Management Bylaw".

1. DEFINITIONS

In this Bylaw:

- a) "**administrator**" shall mean the Administrator of the municipality or its designate as per *The Municipalities Act*;
- b) "**council**" shall mean the council of the Municipality;
- c) "**gross vehicle weight**" shall mean the weight transmitted to the surface of a Highway through any areas of contact between the roadway surface and any vehicle;
- d) "**municipality**" shall mean the Rural Municipality of Rosedale No. 283;
- e) "**highway**" means a road allowance or a road, street or lane vested in the Crown in right of Saskatchewan or set aside for the purposes of the Crown in right of Saskatchewan pursuant to The North-West Territories Act or any Act, and includes anything erected on or in connection with the highway;
- f) "**primary weight**" means primary weights as established by *The Vehicles Weight and Dimension Regulations, 2010*;
- g) "**secondary weight**" means secondary weights as established by *The Vehicles Weight and Dimension Regulations, 2010*; and
- h) "**vehicle**" means a device, object or contrivance in, on or by which a person or thing is or may be transported on a highway and includes: (i) any load on or equipment attached to the vehicle; and (ii) any equipment that may be towed on a highway.

2. VEHICLE WEIGHT RESTRICTION

No person shall, without a permit issued:

- i) Pursuant to Section 6 of this Bylaw; or by the Minister pursuant to section 36 of *The Highways and Transportation Act, 1997*, operate or move or cause to be operated or moved on or over a Municipal Highway, a vehicle, the gross vehicle weight of which exceeds the limits shown in appendix 1 of this Bylaw.
- ii) Municipal Highways listed in Appendix 1 shall be governed by weights limits as defined in *The vehicle weight and Dimensions Regulations, 2010*.

3. BRIDGES AND OTHER INFRASTRUCTURE

No person shall operate or move or cause to be operated or moved on or over any bridge within the municipality, a vehicle, the gross vehicle weight of which exceeds the limits shown in appendix 1 of this Bylaw.

4. VEHICLE WITHOUT RUBBER TIRES AND RUBBER TRACK

Pursuant to Section 6 of this Bylaw, no person shall, without a permit, operate or move or cause to be operated or moved on or over any bridge or Municipal Highway a vehicle without rubber tires and or rubber tracks, the gross vehicle weight of which exceeds 10,000 kilograms.

5. EXEMPTIONS

The restrictions set out in Section 2 and 4 of this Bylaw shall not apply to those vehicles described in Section 3 of *The vehicle weight and Dimensions Regulations, 2010*.

6. OVERWEIGHT PERMIT

- a) Notwithstanding section 2 and 4 of this Bylaw, the Administrator may, if satisfied that the vehicle or combination of vehicles can be operated or moved upon a municipal Highway without damage to the Highway or other property, issue a permit to the registered owner of the vehicle or combination of vehicles to exceed the maximum gross vehicle weights fixed by this Bylaw.
- b) In order to obtain a permit under this section the registered owner must provide to the Administrator:
 - i) proof satisfactory that the vehicle and its load will not exceed the registered gross weight specified in the certificate of registration of the vehicle issued pursuant to *The Traffic Safety Act*; and



- ii) proof of financial responsibility as provided for and in conformity with the requirements of *The Traffic Safety Act*.
- c) Upon approval, as per the Overweight Permit Policy #TS-004, the Administrator will issue an overweight permit to the registered owner of the vehicle or combination of vehicle to exceed the gross weights as set out in *The Vehicles Weight and Dimension Regulations, 2010*.
- d) The administrator shall, in the permit, designate the Municipal Highways that may be used and the vehicle shall then be operated on only such Highways as are designated.
- e) For a single trip permit, the permit number must be provided upon request by a peace officer or the Administrator.
- f) For a multi-trip permit or annual permit, the permit shall be carried in the vehicle and be produced upon request by a peace officer or the Administrator.
- g) Notwithstanding Section 3 of Appendix 1 of this Bylaw, owners of land located on Section 6-31-03 W3 (West of Highway 11) and owners of land located on Section 21 (East of Highway 11), 22, 23, 24, 25, 26, 27, 28, and 29 (East of Highway 11) of 31-03 W3 will be allowed to receive an Annual Permit to operate or move or cause to be operated or moved on or over the road mentioned in Section 3 a) and b) of Appendix 1 of this Bylaw, respectively, a vehicle, having the gross vehicle weight as a Secondary Provincial Highway Weight Standard.
- h) Issuance of all overweight permits are subject to a fee as set out in the Overweight Permit Policy #TS-004 of the Municipality.

7. ROAD BANS

- a) The council may implement road bans within the Municipality pursuant to *The Highways and Transportation Act, 1997*. No person, without a permit, shall use a Highway in contravention when a road ban is in effect.
- b) Annual permit holder, as per Section 6 g) of this Bylaw, shall respect road ban restrictions.

8. ENFORCEMENT


- a) A person who contravenes any provision of this Bylaw is guilty of an offence.
- b) Contraventions of this Bylaw are liable to the penalties referred to in *The Highways and Transportation Act, 1997*, *The Summary Offences Procedure Regulations, 1991*, and the General Penalty Bylaw of the Municipality.
- c) Bylaw No. 01/1978, 02/1984, 09/2007 and 07/2019 are hereby repealed.

**APPENDIX 1
WEIGHT RESTRICTIONS**

1. SECONDARY WEIGHT ROADS

- a) All Highways within the Municipality, unless specified below, are designated as having a Secondary Provincial Highway Weight Standard.

2. PRIMARY WEIGHT ROADS

- a) That portion of Grid Road 764 (Township Road 310) located South of 1, 2 (portion of detour around lake), 3, 4, 5 & 6 of 31-03-W3, South of 1, 2, 3, 4, 5 & 6 of 31-04-W3 and South of 1, 2, 3, 4, 5 & 6 of 31-05-W3.
- b) That portion of Hanley Road (Range Road 3040) located West of 30 & 31 of 29-03 W3 and West of 6, 7, 18, 19, 30 & 31 of 30-03 W3.

3. OTHER WEIGHT ROADS

- a) That portion of Range Road 3040 (a.k.a. "Golf Course Road") located West of Section 6-31-03 W3 shall be restricted to a gross vehicle weight restriction of 8 tonnes all year-round.
- b) That portion of Barr Road (Township Road 305) located South of Section 25, 26, 27 & 28 of 30-03 W3 shall be restricted to a gross vehicle weight restriction of 35 tonnes all year-round.
- c) That portion of Grid Road 764 (Township Road 310) located South of 2-31-03 W3 (portion South of detour around lake) shall be restricted to a gross vehicle weight restriction of 6 tonnes all year-round.
