

RURAL MUNICIPALITY OF ROSEDALE NO. 283

BYLAW NO. 07/2018

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE VILLAGE OF KENASTON RESPECTING THE FUNDING OF THE SWIMMING POOL.

The Council of the Rural Municipality of Rosedale No. 283, in the Province of Saskatchewan enacts as follows:

1. The Rural Municipality of Rosedale No. 283 is hereby authorized to enter into the agreement, attached hereto and forming part of this bylaw, and identified as Exhibit A, with the Village of Kenaston for the purpose stated within the agreement.
2. The Reeve and Administrator of the Rural Municipality of Rosedale No. 283 are hereby authorized to sign and execute the attached agreement identified as Exhibit A.
3. This bylaw shall come into force and take effect from and after the day of final passing thereof.

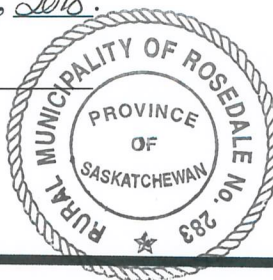




BETWEEN:

Village of Kenaston

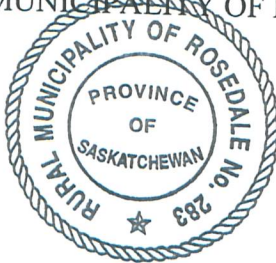
This agreement Witnesses as follows:

1. The parties to this agreement agree to the financial contribution provided by the Rural Municipality of Rosedale no. 283 towards the cost of operating the recreational facility listed below as follow:

2. The parties to this agreement agree that the amount payable by the Rural Municipality of Rosedale No. 283 shall be paid to the Village of Kenaston on or before the 31st day of December in each year.
3. The Village of Kenaston hereby agrees to provide to the Rural Municipality of Rosedale No. 283 such documents and accounting necessary to substantiate the amount of monies expended upon the recreational facility mentioned within this agreement. Such documentation shall be provided on or before the 31st day of January the year following the expenditure of such funds.
4. The Village of Kenaston and the Rural Municipality of Rosedale No. 283 agree that the recreational facility mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of the Rural Municipality of Rosedale No. 283.
5. It is understood and agreed that this agreement shall be continuous but the agreement may be terminated by either party to the agreement giving 30 days' notice in writing.
