A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE VILLAGE OF HAWARDEN RESPECTING THE FUNDING OF THE CENTENNIAL HALL.

The Council of the Rural Municipality of Rosedale No. 283, in the Province of Saskatchewan enacts as follows:



3. This bylaw shall come into force and take effect from and after the day of final passing thereof.

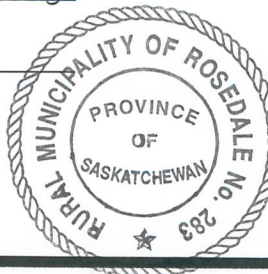

Memorandum of Agreement made this 14 day of August, 2018.

BETWEEN:

AND:

Village of Hawarden

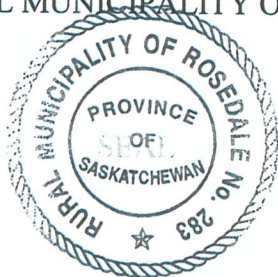
This agreement Witnesses as follows:

1. The parties to this agreement agree to the financial contribution provided by the Rural Municipality of Rosedale no. 283 towards the cost of operating the facility listed below as follow:

2. The parties to this agreement agree that the amount payable by the Rural Municipality of Rosedale No. 283 shall be paid to the Village of Hawarden on or before the 31st day of December in each year.
3. The Village of Hawarden hereby agrees to provide to the Rural Municipality of Rosedale No. 283 such documents and accounting necessary to substantiate the amount of monies expended upon the facility mentioned within this agreement. Such documentation shall be provided on or before the 31st day of January the year following the expenditure of such funds.
4. The Village of Hawarden and the Rural Municipality of Rosedale No. 283 agree that the facility mentioned in this agreement and supported by the amounts also mentioned in this agreement will be available for all residents of the Rural Municipality of Rosedale No. 283.
5. It is understood and agreed that this agreement shall be continuous but the agreement may be terminated by either party to the agreement giving 30 days' notice in writing.

VILLAGE OF HAWARDEN


