- iii) The minimum setback of buildings, including dwellings, from the centreline of a developed road shall be 148ft or 300ft from an intersection of roads;
- iv) Animals shall not be pastured within 50ft of any dwelling not owned by the operator of the pasture or owner of the animals, and no buildings or structures intended to contain birds or animals shall be located within 100ft of a property line;
- v) Four Animal Unit (A.U.) will be permitted on a site of 10 acres; and
- vi) A Building permit is required prior to construction of a dwelling.
